MOTION FOR ORDER REQUIRING COUNSEL TO AMEND ENTRIES OF APPEARANCE

The Plaintiffs United States of America ("United States") and State of New Mexico ex rel. State Engineer ("State") hereby move the Special Master to enter an order requiring all counsel of record, by a date certain, to (1) amend their entries of appearance to identify, by full name, mailing address, and date of joinder or substitution in, all parties they currently represent in this civil action; and (2) file any appropriate motions to withdraw as required by D.N.M.LR-Civ 83.8. As grounds for this motion, Plaintiffs state as follows:

- 1. Over the course of this adjudication counsel have entered appearances which, on the face of the documents or as a result of subsequent events, create ambiguities concerning the persons who are represented:
 - Some entries of appearance list names of individuals or entities that have never been identified as claimants of water rights by the hydrographic survey, joined as parties to this case, or granted leave to intervene.¹
 - Most entries of appearance fail to provide addresses for the persons or entities represented, making it impossible to distinguish the represented persons from other persons in the Zuni River Basin who may have the same or substantially similar names. There are numerous instances where ownership data obtained by the Hydrographic Survey provides differing addresses for persons with identical, or nearly identical, names. Some of these names also have been included on entries of appearance.
 - Some entries of appearance have been filed on behalf of persons previously listed on another entry of appearance, with no withdrawal of, substitution for, or even mention of the previous attorney.
 - During the pendency of this action, there have been numerous changes of ownership of property having surveyed water uses in the Zuni River Basin.

¹ The United States joined defendants listed in its January 19, 2001 *Complaint* (Doc. No. 1) and the August 4, 2003 Amended Complaint (Doc. No. 222). Orders joining additional parties, or granting motions to substitute, are identified in the tables included in Attachment A to this motion. The only order granting intervention in the case (to the Zuni Tribe and the Navajo Nation) was entered July 10, 2002 (Doc. No. 144). Persons or entities not joined,

substituted in, or permitted to intervene, or who have been dismissed, are not parties to this civil action.

These transfers may have caused changes in the representation of individuals previously listed on entries of appearance.

- In particular, it is a common practice for individuals, including individuals
 apparently represented by counsel in this action, to convey their property to a
 trust. However, attorneys who have entered appearances on behalf of the
 individual grantors of such trusts may not have entered appearances on behalf
 of the trusts, which are distinct entities under the law.
- 2. In consequence of the aforementioned factors, the identification of represented parties listed on the Court's caption for this case appears to be unreliable.
- 3. The ambiguities concerning representation in this case can create ethical dilemmas for attorneys with respect to contacts with represented persons. See, e.g., Rule 16-402 NMRA.
- 4. Efforts by Counsel for the United States to obtain clarification from other counsel concerning their representation have frequently received no response.

WHEREFORE, the Plaintiffs respectfully move the Special Master to enter an order requiring all counsel of record, by a date certain, to (1) amend their entries of appearance to identify, by full name, mailing address, and date of joinder or substitution in, all parties they currently represent in this civil action; and (2) file any appropriate motions to withdraw as required by D.N.M.LR-Civ 83.8.
