1.2. Paul Davis and JoAnn V. Davis Revocable Trust dated May 10,

1991. As a consequence of Mrs. Davis's death, the Paul Davis and JoAnn V. Davis

Revocable Trust dated May 10, 1991 was split into two trusts: the Paul Davis Survivor's

entered his appearance on behalf of the two new trusts. The Paul Davis and JoAnn V.

Davis Revocable Trust dated May 10, 1991 should be dismissed as a party to this

matter.

1.3. **The Davis Ltd. Partnership.** The Davis Ltd. Partnership has been

dissolved. Any water rights that The Davis Ltd. Partnership held were transferred to

Paul Davis; the Paul Davis Survivor's Trust dated July 28, 2003; the JoAnn V. Davis

Residual Trust dated July 28, 2003; Pamela Kay Davis; Sage Grae Merrill; Kristi Davis;

and Anita Davis Schafer. Mr. Stripp has filed appearances on behalf of all of the

successors in interest to The Davis Ltd. Partnership. The Davis Ltd. Partnership should

be dismissed as a party to this matter.

WHEREFORE, defense counsel requests that the late JoAnn V. Davis, the Paul

Davis and JoAnn V. Davis Revocable Trust dated May 10, 1991, and The Davis Ltd.

Partnership be dismissed as parties to this matter.
