DECLARATION OF GARY A.  
DURR IN SUPPORT OF  
PLAINTIFF UNITED STATES'  
MOTION FOR DEFAULT  
JUDGMENT

I, Gary A. Durr, am employed as a Paralegal Specialist with the Department of Justice and have been assigned to work in support of Counsel for the United States in the above entitled case.

A. Pursuant to the Order Granting Joint Motion to Amend Procedural and Scheduling Orders and Establish or Revise Deadlines for Defendants to Return Requests for Consultation and Submit Subfile Answers, filed September 27, 2006 (Doc. No. 837), defendants in the Zuni River Basin Adjudication who were sent an initial service packet after the date of the

order, were sent a service packet that included a proposed Consent Order, Request for Consultation form, Notice of Water Rights Adjudication, and if the defendant had not been served process or had not voluntarily waived such service, a copy of the Amended 2003 Complaint, a Request for Waiver of Service of Summons, and two copies of a Waiver of Service of Summons with a prepaid return envelope. The packet also included a letter from the United States explaining the purpose of the forms and to whom and when documents were to be mailed or provided if the defendant chose to respond. The documents were mailed to the defendant's mailing address via certified mail, return receipt requested.

B. The service packet to Christopher Paul Dentzel and Barbara Dentzel Cleary, ZRB-1-0142, was mailed and the return receipt was signed, but was undated. The receipt was signed between the date the packet was mailed, October 6, 2006, and the date the signed receipt was returned and received in this office on October 13, 2006. The Postal Service stamped the date "10 OCT 2006" on the sender's address side of the form, indicating delivery was accomplished on or before October 10, 2006. A copy of Postal Service Form 3811 is attached to this Declaration.

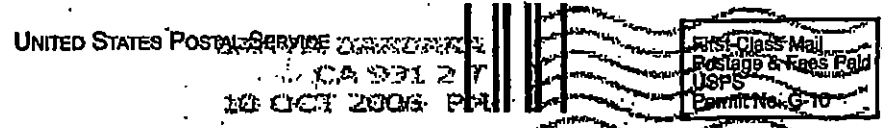
