DECLARATION OF GARY A.  
DURR IN SUPPORT OF  
PLAINTIFF UNITED STATES'  
MOTION FOR DEFAULT  
JUDGMENT

I, Gary A. Durr, am employed as a Paralegal Specialist with the Department of Justice and have been assigned to work in support of counsel for the United States in the above-captioned case.

A. Pursuant to the Procedural and Scheduling Order for the Adjudication of Water Rights Claims in Sub-areas 9 and 10 of the Zuni River Stream System (Doc. No. 436), defendants in the Zuni River Basin Adjudication were sent a service packet that included a proposed Consent Order, Request for Consultation form, Notice of Water Rights Adjudication, a form Answer, and if the defendant had not been served process or had not voluntarily waived

such service, a copy of the Amended 2003 Complaint, a Request for Waiver of Service of Summons, and two copies of a Waiver of Service of Summons with a prepaid return envelope. The packet also included a letter from the United States explaining the purpose of the forms and to whom and when documents were to be mailed or provided if the defendant chose to respond. The documents were mailed to the defendant's mailing address via certified mail, return receipt requested.

B. The service packet to Angie Marez (ZRB-2-0102), was mailed to the defendant's address of record, and the return receipt indicates the packet was received on February 10, 2006. A copy of Postal Service Form 3811 is attached to this Declaration.
