MOTION FOR DEFAULT JUDGMENT

and as grounds therefor Plaintiffs state:

1. The Court has jurisdiction over the above-named defendant as shown by the filed waiver of service of summons of GLORIA ANN HOLDEN (Doc. No. 710).

- 2. GLORIA ANN HOLDEN was provided the documents listed in the Declaration of Gary A. Durr (Exhibit 1) on the dates indicated.
- 3. With respect to Subfile ZRB-3-0080, Defendant GLORIA ANN HOLDEN was subject to the Special Master's March 7, 2006 Procedural and Scheduling Order for the Adjudication of Water Rights Claims in Sub-Area 7 of the Zuni River Stream System (Doc. No. 561)("Procedural and Scheduling Order"), which established deadlines of June 12, 2006, for the submission of a Request for Consultation, and of August 12, 2006, for the return of a signed Consent Order, or filing of a Subfile Answer.
 - 4. These deadlines for Subfile ZRB-3-0080 were never extended.
- 5.
