With respect to Subfile ZRB-3-0088, Defendants ARTHUR KANTER & PATRICIA KANTER were subject to the Special Master's March 7, 2006 Procedural and Scheduling Order for the Adjudication of Water Rights Claims in Sub-Area 7 of the Zuni River Stream System (Doc. No. 561) ("Procedural and Scheduling Order"), which established deadlines of June 12, 2006, for the submission of a Request for Consultation, and of August 12, 2006, for the return of a signed Consent Order, or filing of a Subfile Answer.
