# **MOTION FOR DEFAULT JUDGMENT**

granting default judgment against the following defendants:

and as grounds therefor Plaintiffs state:

1. The Court has jurisdiction over the above-named defendants as shown by

the filed waivers of service of summons of PETER RIEGER and SHEILA RIEGER (Doc. No.

724).

2. PETER RIEGER & SHEILA RIEGER were provided the documents listed in the Declaration of Gary A. Durr (Exhibit 1) on the dates indicated.

3. With respect to Subfile ZRB-3-0138, Defendants PETER RIEGER & SHEILA RIEGER were subject to the Special Master's March 7, 2006 *Procedural and Scheduling Order for the Adjudication of Water Rights Claims in Sub-Area 7 of the Zuni River Stream System* (Doc. No. 561)("Procedural and Scheduling Order"), which established deadlines of June 12, 2006, for the submission of a Request for Consultation, and of August 12, 2006, for the return of a signed Consent Order, or filing of a Subfile Answer.

4. These deadlines for Subfile ZRB-3-0138 were never extended.

5. Defendants PETER RIEGER & SHEILA RIEGER are in default for failure to appear, answer, or otherwise defend in Subfile ZRB-3-0138 within the time limitations imposed by applicable Procedural and Scheduling Orders, or Orders of the Court extending deadlines, as shown by the Clerk's Certificate of Default filed March 3, 2008 (Doc.
