1. The Court has jurisdiction over the above-named defendant as shown by

2. RICHARD DAVIS MALLERY REVOCABLE TRUST was provided the documents listed in the Declaration of Gary A. Durr (Exhibit 1) on the dates indicated.

3. With respect to Subfile ZRB-1-0058, Defendant RICHARD DAVIS MALLERY REVOCABLE TRUST was subject to the Special Master's September 8, 2005 *Amended Procedural and Scheduling Order for the Adjudication of Water Rights Claims in Sub-Areas 4 and 8 of the Zuni River Stream System* (Doc.
