1. The Court has jurisdiction over the above-named defendants as shown by

the filed service of summons on SANDRA L. HOWARD (Doc. No. 1850) and the filed waiver

of service of summons of JOHN L. HOWARD (Doc. No. 958).

2. SANDRA L. HOWARD & JOHN L. HOWARD were provided the documents listed in the Declaration of Gary A. Durr (Exhibit 1) on the dates indicated.

3. With respect to Subfile ZRB-3-0081, Defendants SANDRA L. HOWARD & JOHN L. HOWARD were subject to the Special Master's March 7, 2006 *Procedural and Scheduling Order for the Adjudication of Water Rights Claims in Sub-Area 7 of the Zuni River Stream System* (Doc. No. 561)("Procedural and Scheduling Order"), which established a deadline of August 12, 2006, for the return of a signed Consent Order or the filing of a Subfile Answer.

4. These deadlines for Subfile ZRB-3-0081 were never extended.

5. Defendants SANDRA L. HOWARD & JOHN L.
