NOTICE THAT THE CONSULTATION PERIOD HAS ENDED

Pursuant to the Special Master's Procedural and Scheduling Orders, the United States of America ("United States"), with the concurrence of the State of New Mexico ex rel. State Engineer ("State"), hereby notifies HOFFMAN LIVING TRUST DATED SEPTEMBER 25, 2002 that the consultation period for Subfile No. ZRB-2-0052 has ended. **Within twenty (20) days of the date of service of this notice, HOFFMAN LIVING TRUST DATED SEPTEMBER 25, 2002 must either:**

1. **sign and accept the last Consent Order offered by the United States and the State for Subfile No. ZRB-2-0052 and return the entire Consent Order to counsel for the United States, OR**
2. **file with the Court and serve on counsel for the United States and for the State a Subfile Answer.**

A form Subfile Answer is provided with this notice. You may use the provided form or prepare your own Subfile Answer. However, in order to satisfy the Court's requirements, your Subfile Answer must:

1. provide the caption and civil action number of this case (No. 01cv00072-BB) and identify the subfile by the subfile number (ZRB-2-0052),
2. explain your reasons for disagreeing with the Consent Order offered for the subfile by the United States and the State,
3. include a statement that you have made a good faith effort to consult with and resolve the disagreement with the United States and the State, and
4. be properly filed with the Clerk of Court and served by mailing a copy to both counsel for the United States and counsel for the State.

Failure to properly sign and return the last-offered Consent Order or file and serve a Subfile Answer within twenty (20) days of service of this Notice shall be considered grounds for entry of a default order incorporating the terms jointly proposed by the United States and the State.
