A. Pursuant to the Procedural and Scheduling Order for the Adjudication of Water Rights Claims (Doc. No. 954), Defendants in Sub-area Ramah of the Zuni River Basin Adjudication were provided a service packet that included a proposed Consent Order, Request for Consultation form, Notice of Water Rights Adjudication, and if the defendant had not been served process or had not voluntarily waived such service, a copy of the Amended 2003 Complaint, a Request for Waiver of Service of Summons, and two copies of a Waiver of Service of Summons with a prepaid return envelope.
