It is understood that this disclaimer does not prejudice the right of the undersigned and/or his/her successor(s)-in-interest from petitioning in the future the State Engineer for a permit to put surface and/or groundwater in the Zuni River Basin to beneficial use nor does this disclaimer preclude the State Engineer from granting the undersigned and/or his/her successor(s)-in-interest a right to beneficially use the surface and/or groundwater in the Zuni River Basin. It is further understood that the priority date of a water right permit granted under the laws of the State of New Mexico can not be earlier than the date of this disclaimer.

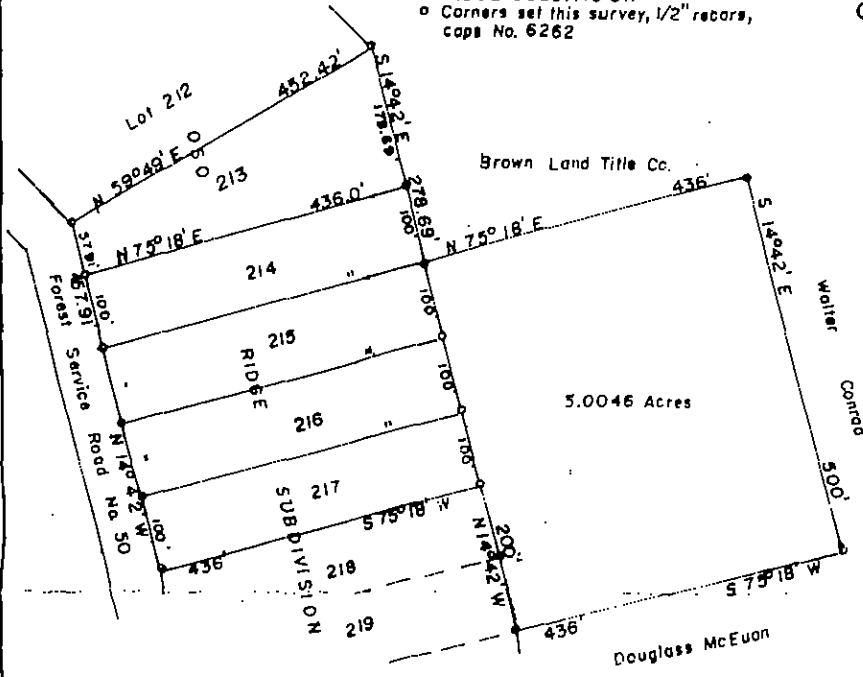

Lots numbered 213, 214, 215, 216, and 217, in OSO RIDGE SUBDIVISION, a subdivision in Section 9, T9N, R12W, NMPM, Cibola County, New Mexico, as the same are shown and designated on the Plat thereof filed in the office of the County Clerk of Valencia County, New Mexico, on March 7, 1967: plus approximately five acres measuring 500 feet by 436 feet deep along the back of Lots 215, 216, 217, 218, and 219, lying in Sections 9 and 10, T9N, R12W, NMPM, Cibola County, New Mexico, and being more particularly described as follows:

Beginning at the southwest corner of said tract, which is also the southeast corner of Lot 219, OSO RIDGE SUBDIVISION; thence N 14°42' W, 500 feet to the northwest corner; thence N 75°18' E, 436 feet to the northeast corner of said tract; thence S 14°42' E, 500 feet to the southeast corner; thence S 75°18' W, 436 feet to the place of beginning and containing 5.0046 acres, more or less.

Total acreage is 10.1923 acres.

This is to certify that this plat and the survey on which it is based were made in accordance with the "Minimum Standard Detail Requirements for Land Title Surveys" jointly adopted and established by ATA and ACSM in 1962.

As shown on the Flood Hazard Boundary Map, Cibola County, New Mexico (Unincorporated Areas), Panel 400 of 1225, Community-Panel No. 350145 0400 A, dated July 2, 1984, the above described real estate is located in Flood Zone C, i.e., an area of minimal flood hazard.
