and as grounds therefor Plaintiffs state:

1. The Court has jurisdiction over the above-named defendant as shown by the filed service of summons on FRED SCOTT (Doc. No. 1997).

- 2. FRED SCOTT was provided the documents listed in the Declaration of Khaleelah E. Jones (Exhibit 1) on the dates indicated.
- 3. With respect to Subfile ZRB-1-0128, Defendant FRED SCOTT was subject to the Special Master's September 8, 2005 Amended Procedural and Scheduling Order for the Adjudication of Water Rights Claims in Sub-Areas 4 and 8 of the Zuni River Stream System (Doc. No. 387)("Procedural and Scheduling Order"), which established a deadline of January 10, 2006 for the submission of a Request for Consultation or the return of a signed Consent Order.
 - 4. These deadlines for Subfile ZRB-1-0128 were never extended.
- 5. In addition, Defendant FRED SCOTT failed to answer after being served with a summons.
- 6. Defendant FRED SCOTT is in default for failure to appear, answer, or otherwise defend in Subfile ZRB-1-0128 within the time limitations imposed by the Federal Rules of Civil Procedure, applicable Procedural and Scheduling Orders, or Orders of the Court extending deadlines, as shown by the Clerk's Certificate of Default filed December 17, 2008 (Doc. No. 2013).
