**ORDER GRANTING JOINT MOTION TO AMEND SCHEDULING ORDER**

This matter is before the Special Master following the February 9, 2011 status conference on the November 9, 2010 *Joint Motion to Amend Scheduling Order* (No. 2619) filed by the State of New Mexico *ex rel.* State Engineer (“State”) and the United States of America (“United States”), with the concurrence of the Zuni Indian Tribe and the Navajo Nation. No party has objected to the joint motion and, and after consultation between the parties on the proposed schedule and for good cause shown, the motion is hereby GRANTED.

It is hereby ORDERED that the *Preliminary Procedural and Scheduling Order for Subproceeding 2* (No. 1767) filed May 21, 2008, as amended by the December 4, 2009 *Order Granting Joint Motion to Amend Navajo Indian Claims Scheduling Order* (No. 2487), be amended as follows:
