


such service, a copy of the Amended 2003 Complaint, a Request for Waiver of Service of Summons, and two copies of a Waiver of Service of Summons with a prepaid return envelope. The packet also included a letter from the United States explaining the purpose of the forms and to whom and when documents were to be mailed or provided if the Defendants chose to respond. The documents were mailed to the Defendant's mailing address via certified mail, return receipt requested.

B. The service packet to Jerry and Virginia Clark (ZRB-3-0201), was mailed to the Defendants' address of record. The original Postal Service Form 3811, Domestic Return Receipt was returned signed and dated August 27, 2010. A copy of Postal Service Form 3811 is attached to this declaration.


C. Pursuant to the Servicemembers Civil Relief Act, 50 App. U.S.C.A. § 521 (2012), a search was conducted in the following databases to determine if the Defendants, Jerry Clark and Virginia Clark, are currently in active military service: Westlaw - People Finder, LexisNexis - Military Finder, and the Servicemembers Civil Relief Act (SCRA) website. These sources do not indicate that Defendants are on active military duty status.
