MOTION OF SPECIAL MASTER FOR INTERIM FEES AND EXPENSES

A Motion requesting the Court to approve interim fees and expenses, a brief summary of the work performed, and the Special Master's Declaration in support of Motion

This Motion is submitted pursuant to the Administrative Order entered May 4, 2001 (Docket No. 54), regarding the manner in which the Special Master, data manager and other personnel required by the Special Master are paid for services, costs, expenses and New Mexico gross receipts taxes related to this adjudication. The Special Master hereby moves for an order of the Court

approving interim fees and expenses for work performed in this case from July 1, 2003 through

December 31, 2004. Most of the fees and expenses have already been paid from the trust account.

I. WORK PERFORMED

General case management work dedicated to structuring the adjudication continued. I

entered a July 20 Procedural and Scheduling Order setting out general procedures, including the

hydrographic survey process. Following a September 9 status conference on federal and Indian water

rights claims, I filed a Special Master's Report and Recommendations for Federal and Indian Water

Rights Claims Proceedings. Work on general procedures as well as scheduling continues. In general

administrative matters, I produced a first draft of a proposed administrative order which would

facilitate filing and notice by electronic means. The Court's data manager has begun construction of

a data base for the Court's use.
