COMMENTS OF DEFENDANTS RICHARD DAVIS MALLERY *ET AL.* TO PROPOSED SCHEDULING ORDER

In accordance with the Special Master's instructions during the November 9, 2005 status conference, Defendant Richard Davis Mallery, Western New Mexico Water Preservation Association ("WNMWPA"), presents the following comments on the proposed Scheduling Order for Sections 9 and 11 of the Zuni Basin.

COMMENTS

The prevailing comment received from the membership of the WNMWPA regarding the recent service of Consent Orders in sections 4 and 8 of the Zuni Basin has been that there was no deadline stated for the submission of requests for consultation when the water user did not agree with the specifics of the Consent Order. Recipients of the Consent Orders are expressing confusion as to whether the deadline for submitting an Answer is also the deadline for requesting consultation.

The proposed Scheduling Order for sections 9 and 11 suffers from this same infirmity. There is no specified deadline for returning a request for consultation. WNMWPA believes that a specific deadline for the return of a request for consultation will alleviate the confusion that has accompanied the recent service of the Consent Orders for sections 4 and 8.

The WNMWPA thanks the Special Master for the opportunity to comment on the proposed Order.
