MOTION TO EXTEND TIME FOR FILING SUBFILE ANSWERS IN SUBFILES REQUIRING NEW SERVICE PACKET MAILINGS

The Plaintiffs United States of America ("United States") and the State of New Mexico ex rel. State Engineer ("State") hereby move the Special Master to extend to March 27, 2006, the deadline for filing answers established by the *Amended Procedural and Scheduling Order for the Adjudication of Water Rights Claims in Sub-Areas 4 and 8 of the Zuni River Stream System* ("Amended Procedural and Scheduling Order") (Doc. No. 387), with respect to the Subfiles listed on Exhibit A hereto. In addition, Plaintiffs move the Special Master to require defendants in any Subfile listed on Exhibit A to return a *Request for Consultation* to the United States by February 24, 2006, if they disagree with any element of the *Consent Order* proposed by Plaintiffs for such Subfile. In support of this motion, Plaintiffs assert: 1. At the end of September 2005, the United States mailed 101 subfile service packets, pursuant to the Amended Procedural and Scheduling Order, to all defendants in Sub-areas 4 and 8. Of these subfile packets, 23 have been returned by the Post Office as undeliverable. In addition, updated address and ownership information obtained from defendants, defendants' counsel, and county offices has indicated that property involved in these subfiles, and others, has been transferred and/or subdivided since the hydrographic survey was completed for Sub-areas 4 and 8. In consequence, it is now necessary to mail service packets concerning 29 subfiles to defendants in Sub-areas 4 and 8 who have not previously received such packets.

2. Many, though not all, of the proposed consent orders to be sent to the defendants listed on Exhibit A, due to revisions, or wear and tear on originals previously mailed, must first be transmitted for review by the State and signature by counsel for the State, before being returned to the United States for delivery to the defendants. Given the holiday season, and the reliability of the mails, this process may consume 40 days.

3. An additional 60 days should be allowed for defendants listed on Exhibit A to consider, respond to, and engage in consultation concerning, the proposed consent orders, before being required to file subfile answers.

4. Comments received from defendants and counsel with respect to the original service packet mailing for Subareas 4 and 8 indicate a need for the Special Master to establish a date certain by which defendants must return *Request for Consultation* forms. Plaintiffs suggest this deadline should be set at least 30 days before the deadline for filing subfile answers.

Motion To Extend Time For Filing Subfile Answers In Subfiles Requiring New Service Packet Mailings, Page 2 Accordingly, the Plaintiffs respectfully move the Special Master to extend to March 27, 2006, the deadline for defendants in the subfiles listed on Exhibit A to file subfile answers, and to require defendants in such subfiles to return a *Request for Consultation* to the United States by February 24, 2006, if they disagree with any element of the *Consent Order* proposed by Plaintiffs.
