MOTION FOR SUBSTITUTION OF PARTY

The Plaintiffs United States of America ("United States") and State of New Mexico ex rel. State Engineer ("State") hereby move the Court pursuant to Fed. R. Civ. P. 25(c) to issue its order (1) substituting PATRICK A. MAHER for defendant BETTY J. MAHER in these proceedings, (2) deeming the filed Waiver of Service of Summons bearing the typewritten name of Betty J. Maher crossed out and replaced by the hand-printed name of Patrick A. Maher and signed by Patrick A. Maher to be a valid waiver of service by the defendant Patrick A. Maher, and (3) permitting the United States to submit for Court approval a Consent Order originally issued to Betty J. Maher, but having that name crossed out and replaced by the hand-printed name of Patrick A. Maher, and bearing the signature of Patrick A. Maher. As grounds for this motion, Plaintiffs state as follows:

- 1. Pursuant to the Special Master's March 7, 2006 *Procedural and Scheduling Order for the Adjudication of Water Rights Claims in Sub-Area 7 of the Zuni River System* (Doc. No. 561) and based upon information obtained from Cibola County records for the Hydrographic Survey of Sub-area 7, the United States, on March 31, 2006, filed a *Motion To Join Additional Parties Defendant* (Doc. No. 615), requesting the Court to join Betty J. Maher, among others, as a party defendant in this case. The Court granted the motion on April 5, 2006. (Doc. No. 616).
- 2. Also pursuant to the Special Master's procedural and scheduling order, the United States served a proposed Consent Order for Subfile ZRB-3-0099, signed by counsel for the United States and the State, upon Betty J. Maher. The service packet, mailed on May 12, 2006, included waiver of service of summons documents for Betty J. Maher, who had not previously waived service.
- 3. Patrick A. Maher is the son of Betty J. Maher. He signed the Waiver of Service of Summons originally bearing the typewritten name of Betty J. Maher on May 24, 2006, substituting his own hand-printed name for the typewritten name of his mother. He also indicated on the waiver form that Betty J. Maher was deceased and that he, Patrick A. Maher is her heir. The waiver is being submitted to the Clerk for filing contemporaneously with this motion.
- 4. On June 12, 2006, the Consent Order proposed by the United States and the State for Subfile ZRB-3-0099 was returned to the United States together with the Request for Consultation form for the subfile. On the Consent Order, Mr. Maher again struck out and substituted his own hand-printed name for each typewritten instance of his mother's name and

signed the document in his own name. On the Request for Consultation, Mr. Maher indicated

that his mother was deceased and that he was the sole heir to the property involved in Subfile

ZRB-3-0099. Attached to the Request for Consultation were copies of documents, including a

Quitclaim Deed by which Mr. Maher's sister, Deborah J. Blanchard, quitclaimed the property

involved in this subfile to Mr. Maher, and a Default Judgment entered July 7, 2004 in Patrick A.

Maher v. Unknown Heirs of Betty Jean Maher, No. D1333-PB-20040011 (13th Jud. Dist., Cibola

County, N.M.). The Default Judgment, inter alia, quieted Mr. Maher's title to the subject

property.

WHEREFORE, the Plaintiffs respectfully move the Court to enter its order (1)

substituting PATRICK A. MAHER for defendant BETTY J. MAHER in these proceedings, (2)

finding the filed Waiver of Service of Summons bearing the typewritten name of Betty J. Maher

crossed out and replaced by the hand-printed name of Patrick A. Maher and signed by Patrick A.

Maher to be a valid waiver of service by the defendant Patrick A. Maher, and (3) permitting the

United States to submit for Court approval a Consent Order originally issued to Betty J. Maher,

but having that name crossed out and replaced by the hand-printed name of Patrick A. Maher and

bearing the signature of Patrick A. Maher.
