MOTION FOR SUBSTITUTION OF PARTY

The Plaintiffs United States of America ("United States") and State of New Mexico ex rel. State Engineer ("State") hereby move the Court pursuant to Fed. R. Civ. P. 25(a) to issue its order substituting the ESTATE OF DEREK OSBORNE BEATON for defendant DEREK OSBORNE BEATON in these proceedings. As grounds for this motion, Plaintiffs state as follows:

1. Pursuant to the Special Master's December 14, 2005 *Procedural and Scheduling Order for the Adjudication of Water Rights Claims in Sub-Areas 9 and 10 of the Zuni River System* (Doc. No. 436) and based upon information obtained from Cibola County records for the Hydrographic Survey of Sub-areas 9 and 10, the United States, on January 24, 2006, filed a *Motion To Join Additional Parties Defendant* (Doc. No. 468), requesting the Court to join

Derek Osborne Beaton, among others, as a party defendant in this case. The Court granted the

motion on January 26, 2006. (Doc. No. 470).

2. Also pursuant to the Special Master's procedural and scheduling order, the

United States mailed a proposed Consent Order for Subfile ZRB-2-0015, signed by counsel for

the United States and the State, to Derek Osborne Beaton. The service packet, mailed on

February 2, 2006, was returned by the post office as undeliverable.

3. On July 26, 2006, Ronald Boyett provided counsel for the United States

with copies of the May 16, 2006 Order of Presumed Death and Intestacy, Determination of

Heirs and Appointment of Personal Representative without Bond in a Supervised Administration

entered on the record of In the Matter of Derek Osborne Beaton, Missing and Presumed Dead,

No. D-0728-PB-2006-005 (7th Dist., N.M.), together with a certified copy of the June 15, 2006

Statement of Acceptance of Appointment as and Duties of the Office of Personal Representative

filed in that action by Mr. Boyett.²

WHEREFORE, the Plaintiffs respectfully move the Court to enter its order

substituting the ESTATE OF DEREK OSBORNE BEATON for defendant DEREK OSBORNE

BEATON in these proceedings.
