MOTION TO CORRECT DEFENDANT'S NAME

COMES NOW the Plaintiff United States of America ("United States") and moves the Court to issue its order correcting the name of the defendant specified below to read as follows:

FROM TO

ALICE K. COHO ALICE JAMES

The United States further moves the Court to order that the United States may submit to the Special Master, for her review and Court approval, a Consent Order issued to Ray K. Coho and Alice K. Coho, but bearing the signatures of Ray K. Coho and Alice James. In support of this motion, the United States asserts:

- 1. "Coho, Ray K. & Alice K." were named as defendants in the United States original Complaint in this action. [Doc. No. 1]
- 2. Based on name information contained in Cibola County property records, the United States has mailed (1) Waiver Of Service Of Summons forms, (2) a Request For Consultation form, and (3) a proposed Consent Order bearing the printed names of Ray K. Coho and Alice K. Coho to P.O. Box 245, Pinehill, NM 87357. As indicated by the Exhibits submitted with this motion, each of these documents has been returned bearing the signatures of Ray K. Coho and Alice James (in two instances, "Alice K. James"). The first name and middle initial (where provided) of Ms. James' signature on these documents are the same as that provided by Cibola County records, and by her signing of the documents in question, she appears to hold herself out to be the co-owner, with Defendant Ray K. Coho, of the property, including water rights, involved in Subfile ZRB-3-0034.
- 3. The "Form A" *Change of Address or Ownership Form*, dated June 10, 2006 and submitted herewith as Exhibit 5, is signed by Ray K. Coho and Alice James and indicates that the former defendant's address "Alice K. Coho, POB 245, Pinehill, NM 87357" should be changed to Alice James, POB 186, Pinehill, NM."
- 4. Counsel for the United States otherwise has no reason to doubt that Alice James is the correct name of the defendant in question.

WHEREFORE, the United States moves the Court to enter an order (1) correcting the defendant's name "ALICE K. COHO" to "ALICE JAMES", and (2) permitting the United States to submit to the Special Master, for her review and Court approval, a Consent Order
