(3) dismissing DANIEL W. BOLLER, in his individual capacity, as a party defendant from this

The Court finds that the motion is well-taken and, for good cause shown, should

be GRANTED.

IT IS THEREFORE ORDERED that the name of the defendant "KATHLEEN M.

BOLLER REVOCABLE LIVING TRUST" be corrected to "DANIEL W. BOLLER &

KATHLEEN M. BOLLER REVOCABLE LIVING TRUST."

IT IS FURTHER ORDERED that the United States may file the Waiver of

Service of Summons bearing the printed name "Kathleen M. Boller Revocable Living Trust" but

signed by Kathleen M. Boller in her capacity as Trustee for the "Daniel Winslip Boller and

Kathleen Marlow Boller Revocable Living Trust U/A 1995" and the same shall be deemed an

effective waiver of service of summons on behalf of the Daniel W. Boller & Kathleen M. Boller

Revocable Living Trust.

IT IS FURTHER ORDERED that DANIEL W. BOLLER, in his individual

capacity, be, and hereby is, dismissed as a party defendant from this case.
