PETITION FOR ACCESS TO CM/ECF SYSTEM**

Pursuant to the United States District Court Administrative Order dated August 28, 2006 and in compliance with the CM/ECF Administrative Procedures Manual for the United States District Court, District of New Mexico (dated August 28, 2006 and revised December 29, 2006), Edward J. Bawolek and Suzan J. Bawolek (hereinafter "Bawoleks"), defendants *pro se*, respectfully request the Court's permission to utilize the CM/ECF system for electronic filings in the above-captioned matter.

The Bawoleks move this Court to enter an order granting permission to use CM/ECF on the following grounds:

1. As authorized by Administrative Order effective August 28, 2006, and Local Rules, unless otherwise excepted, electronic filing is mandatory in the United States District Court for the District of New Mexico.


2. The Bawoleks have filed a Notice of Appearance as defendants *pro se*.
3. The Bawoleks have been granted use of the CM/ECF system in the related action No. 01cv00072 MV/LFG, and have utilized the system in compliance with the Court's electronic filing requirements in said action.
4. The Bawoleks have reviewed the CM/ECF Administrative Procedures Manual and the associated training materials for the CM/ECF system and believe that they can properly utilize the system to comply with the Court's electronic filing requirements in this action.

Opposing counsel was not consulted with respect to this Petition since this motion is mandated by Administrative Order and only affects the rights of the Bawoleks as those rights apply to the Bawoleks' relationship with the Court.

WHEREFORE, the Bawoleks request that the Court enter an Order allowing the Bawoleks to adopt the use of the CM/ECF system for filings as defendants *pro se* in this Action.
