**ORDER GRANTING MOTION TO CORRECT DEFENDANT’S NAME**

This matter is before the Court upon the *Motion to Correct Defendant’s Name* filed September 4, 2007 by the Plaintiff United States of America (“United States”) (Doc. No. 1253). The United States’ motion seeks an order (1) correcting the name of the defendant SCOTT CURTIS” to “SCOTT BLOOM,” (2) permitting the United States to submit as a valid waiver of service of summons by Scott Bloom a Waiver of Service of Summons form issued to Scott Curtis, but bearing the signature of “Scott C. Bloom” and hand-printed name “Scott Curtis Bloom,” and (3) permitting the United States to submit to the Special Master, for her review and Court approval, a Consent Order for Subfile ZRB-4-0049 issued to Stanton Bloom, Lois Bloom, & Scott Curtis, but bearing the signatures of Stanton Bloom, Lois Ann Bloom, and Scott C. Bloom.

The Court finds that the motion is well-taken and, for good cause shown, should be GRANTED.

IT IS THEREFORE ORDERED that the name of the defendant "SCOTT CURTIS" be corrected to "SCOTT BLOOM."

IT IS FURTHER ORDERED that the Waiver of Service of Summons form signed by the defendant Scott Bloom is a valid waiver of service by the defendant and may be submitted for filing by the United States, notwithstanding the error in the typewritten name on the form.


IT IS FURTHER ORDERED that the Consent Order for Subfile ZRB-4-0049 signed by the defendants Scott Bloom, Stanton Bloom, and Lois Bloom may be submitted for Court approval, notwithstanding the typewritten error concerning Scott Bloom's name on the document.
