# MOTION FOR DEFAULT JUDGMENT

The Plaintiffs United States of America ("United States") and New Mexico ex rel. State Engineer ("State"), pursuant to Fed. R. Civ P. 55(b)(2), move the Court to enter its order granting default judgment against the following defendants:

and as grounds therefor Plaintiffs state:

The Court has jurisdiction over the above-named defendants as shown by 1. filed service of summons on ANN HEATH (Doc. No. 647) and RICHARD HEATH (Doc. No. 648).

- 2. ANN HEATH & RICHARD HEATH were provided the documents listed in the Declaration of Gary A. Durr (Exhibit 1) on the dates indicated.
- 3. With respect to Subfile ZRB-1-0028, Defendants ANN HEATH & RICHARD HEATH were subject to the Special Master's September 8, 2005 Amended Procedural and Scheduling Order for the Adjudication of Water Rights Claims in Sub-Areas 4 and 8 of the Zuni River Stream System (Doc. No. 387) ("Procedural and Scheduling Order"), which established a deadline of January 10, 2006, for the return of a Consent Order, or the filing of a form Subfile Answer.
- 4. These deadlines for Subfile ZRB-1-0028 were extended by the Order Granting Motion to Extend Time for Persons Served with a Summons to File Subfile Answers (Doc. No. 442), which extended the deadline to file a subfile answer to 20 days after service of summons and the Amended 2003 Complaint.
- 5. Defendants ANN HEATH & RICHARD HEATH are in default for failure to appear, answer, or otherwise defend in Subfile ZRB-1-0028 within the time limitations imposed by applicable Procedural and Scheduling Orders, or Orders of the Court extending deadlines, as shown by the Clerk's Certificate of Default filed August 28, 2007 (Doc.
