


form, Notice of Water Rights Adjudication, and if the defendant had not been served process or had not voluntarily waived such service, a copy of the Amended 2003 Complaint, a Request for Waiver of Service of Summons, and two copies of a Waiver of Service of Summons with a prepaid return envelope. The packet also included a letter from the United States explaining the purpose of the forms and to whom and when documents were to be mailed or provided if the defendant chose to respond. The documents were mailed to the defendant's mailing address or counsel of record via certified mail, return receipt requested.

B. The service packet for Leyton J. Cougar (ZRB-3-0188), was mailed to the defendant's address of record, and was received on March 18, 2009. A copy of Postal Service Form 3811 is attached to this Declaration.
