A. Defendants in the Zuni River Basin Adjudication, Sub-areas 4 and 8, pursuant to the Special Master's Procedural and Scheduling Order for the Adjudication of Water Rights Claims in Sub-areas 4 and 8 of the Zuni River Stream System (Doc. No. 387), were sent a service packet that included a proposed Consent Order, Request for Consultation form, a form

The packet also included a letter from the United States explaining the purpose of the forms and to whom and when documents were to be mailed or provided if the defendant chose to respond. The documents were mailed to the defendant's mailing address via certified mail, return receipt requested.

B. The service packet to Maureen Kearns and Robert Kammerer Trust, ZRB-1-0049, was mailed to the defendant's address of record, and the return receipt was signed but undated. Using USPS Track and Confirm indicates the packet was received at 11:58 AM on October 4, 2007. The defendant did not respond. A copy of Postal Service Form 3811 and Track and Confirm sheet is attached to this Declaration.

C. The defendant Maureen Kearns and Robert Kammerer Trust, ZRB-1-0049, was served by Publication in the *Gallup Independent* and *Albuquerque Journal* for three consecutive weeks beginning May 27, 2009 and ending June 10, 2009 (Doc. No. 2379).
