I, Khaleelah Jones, am employed as a Paralegal Specialist with the Department of Justice and have been assigned to work in support of Counsel for the United States in the above entitled case.

A. Defendants in the Zuni River Basin Adjudication, Sub Area 6, pursuant to the *Supplemental Procedural and Scheduling Order for the Adjudication of Certain Water Rights Claims in Sub-Area 6 of the Zuni River Stream System* (Doc. No. 1733), were sent a service packet that included a proposed Consent Order, Request for Consultation form, a form Answer, Notice of Water Rights Adjudication, and if the defendant had not been served process

or had not voluntarily waived such service, a copy of the Amended 2003 Complaint, a Request for Waiver of Service of Summons, and two copies of a Waiver of Service of Summons with a prepaid return envelope. The packet also included a letter from the United States explaining the purpose of the forms and to whom and when documents were to be mailed or provided if the defendant chose to respond. The documents were mailed to the defendant's mailing address via certified mail, return receipt requested.
