The packet also included a letter from the United States explaining the purpose of the forms and to whom and when documents were to be mailed or provided if the defendant chose to respond. The documents were mailed to the defendant's mailing address via certified mail, return receipt requested.

B. The service packet to Sefferino Eriacho and Loretta Eriacho, ZRB-6-0002, was mailed to the defendant's address of record and the return receipt was signed but undated. USPS Track and Confirm indicates that the packet was delivered at 5:00 PM on April 28, 2008. A copy of Postal Service Form 3811 and the USPS Track and Confirm slip are attached to this Declaration.
