I, Khaleelah E. Jones, am employed as a Paralegal Specialist with the Department of Justice and have been assigned to work in support of counsel for the United States in the above-captioned case.

A. Defendants in the Zuni River Basin Adjudication, Sub-areas 9 and 10, who were sent a service packet after the Order Granting Joint Motion to Amend Procedural and Scheduling Orders and Establish or Revise Deadlines for Defendants to Return Requests for Consultation and Submit Subfile Answers (Doc. No. 837), filed September 27, 2006, were provided a service packet that included a proposed Consent Order, Request for Consultation

form, Notice of Water Rights Adjudication, and if the defendant had not been served process or had not voluntarily waived such service, a copy of the Amended 2003 Complaint, a Request for Waiver of Service of Summons, and two copies of a Waiver of Service of Summons with a prepaid return envelope. The packet also included a letter from the United States explaining the purpose of the forms and to whom and when documents were to be mailed or provided if the defendant chose to respond. The documents were mailed to the defendant's mailing address via certified mail, return receipt requested.

B. The service packet to Eugenio Landavazo (ZRB-2-0060), was mailed to the defendants's address of record, and the return receipt was signed by Vedna Landavazo. Although the return receipt is not dated by Vedna Landavazo, the Zuni post office date stamped the receipt, indicating it was received February 6, 2006. A copy of Postal Service Form 3811 is attached to this Declaration.

C. A waiver of service of summons was returned by Vedna Landavazo, signed February 6, 2006, in which she stated that her husband, Eugenio Landavazo, was deceased. On August 13, 2007, counsel for the United States wrote a letter to Vedna Landavazo regarding ownership of the property for subfile ZRB-2-0060. A return receipt for the letter was signed by Vedna Landavazo, dated August 15, 2007. No response to the letter was received. A copy of the letter and Postal Service Form 3811 is attached to this declaration.

D. The Unknown Heirs of Eugenio Landavazo (ZRB-2-0060) were served by Publication for three consecutive weeks beginning May 27, 2009 and ending June 10, 2009 in the Gallup Independent and Albuquerque Journal (Doc. No. 2379).

Dear Mrs. Landavazo:

Since receiving the Waiver of Service of Summons that you returned in February of last year on behalf of your deceased husband Eugenio, we have been waiting for the Cibola County records to indicate updated ownership information for the property involved in Subfile ZRB-2-0060. Unfortunately, the data we are able to obtain from the County still show Eugenio Landavazo as the sole owner of the property.

State law (72-4-17 NMSA 1978) provides that when we cannot determine the successors in interest to a deceased person we should join "the unknown heirs of such deceased person" as the parties to the adjudication. However, it will avoid legal complications for the heir or heirs if we can name them. Accordingly, I am requesting that you provide a copy of any documentation you may have that indicates who the current owner or owners of the property may be. A deed to the property issued as a result of the administration of your late husband's estate would be sufficient.

I am sorry to have to bother you with this, and thank you in advance for your cooperation. If you have any questions concerning this request, please feel free to give me a call.
