**MOTION FOR DEFAULT JUDGMENT**

The Plaintiffs United States of America (“United States”) and New Mexico ex rel. State Engineer (“State”), pursuant to Fed. R. Civ P. 55(b)(2), move the Court to enter its order granting default judgment against the following defendants:

and as grounds therefor Plaintiffs state:

1. The Court has jurisdiction over the above-named defendants as shown by the filed service of summons on CARLA FERONG and KONRAD KNOLL (Doc. No. 1853)

and the filed waivers of service of summons of JOHN C. BYINGTON (Doc. No. 727) and DEBBIE A. BYINGTON (Doc. No. 362).

2. DEBBIE A. BYINGTON & JOHN C. BYINGTON & KONRAD KNOLL & CARLA FERONG were provided the documents listed in the Declaration of Khaleelah E. Jones (Exhibit 1) on the dates indicated.

3. With respect to Subfile ZRB-3-0022, Defendants DEBBIE A. BYINGTON & JOHN C. BYINGTON & KONRAD KNOLL & CARLA FERONG were subject to the Special Master's March 7, 2006 *Procedural and Scheduling Order for the Adjudication of Water Rights Claims in Sub-Area 7 of the Zuni River Stream System* (Doc. No. 561)("Procedural and Scheduling Order"), which established a deadline of August 12, 2006 for the submission of a Request for Consultation or the return of a signed Consent Order.

4. These deadlines for Subfile ZRB-3-0022 were never extended.

5. Defendants DEBBIE A. BYINGTON & JOHN C. BYINGTON & KONRAD KNOLL & CARLA FERONG are in default for failure to appear, answer, or otherwise defend in Subfile ZRB-3-0022 within the time limitations imposed by applicable Procedural and Scheduling Orders, or Orders of the Court extending deadlines, as shown by the Clerk's Certificate of Default filed October 8, 2008 (Doc. No. 1908).

6. In accordance with the *Zuni River Basin Adjudication Hydrographic Survey Report for Sub Area 7*, as amended, the right(s) of DEBBIE A. BYINGTON & JOHN C. BYINGTON & KONRAD KNOLL & CARLA FERONG to divert and use the public waters of the Zuni River Stream System, Sub-Area 7, should be as set forth below:
