A. Defendants in the Zuni River Basin Adjudication, Sub-areas 9 and 10, who were sent a service packet after the Order Granting Joint Motion to Amend Procedural and Scheduling Orders and Establish or Revise Deadlines for Defendants to Return Requests for Consultation and Submit Subfile Answers (Doc. No. 837), filed September 27, 2006, were provided a service packet that included a proposed Consent Order, Request for Consultation

form, Notice of Water Rights Adjudication, and if the defendant had not been served process or had not voluntarily waived such service, a copy of the Amended 2003 Complaint, a Request for Waiver of Service of Summons, and two copies of a Waiver of Service of Summons with a prepaid return envelope.
