MOTION OF SPECIAL MASTER FOR INTERIM FEES AND EXPENSES

TO: The Honorable Bruce D. Black FROM: Vickie L. Gabin United States District Judge Special Master

A Motion requesting the Court to approve interim fees and expenses, a brief summary of the work performed, and the Special Master's Declaration in support of Motion

This Motion is submitted pursuant to the Administrative Order entered May 4, 2001 (Docket No. 54), regarding the manner in which the Special Master, data manager and other personnel required by the Special Master are paid for services, costs, expenses and New Mexico gross receipts taxes related to this adjudication. The Special Master hereby moves for an order of the Court approving the work performed in this case from January 1, 2011, through June 30, 2011, as described herein, and the manner by which fees and expenses have been paid from the trust account.

I. WORK PERFORMED

A. General Case Management

The Court's data manager continues to build the Court's data base which will track all pleadings and will be used to produce a partial final decree for non-federal rights.

B. Federal and Indian Claims

At the February 9, 2011, status conference, the parties described the severe resource constraints which limit their litigating the various federal Indian water rights claims already scheduled in the federal adjudications. The parties involved in the adjudication of the water rights claims of the Zuni Indian Tribe and Navajo Nation requested, and I entered, new scheduling orders on April 20, 2011 (No. 2650 in 01cv072; No. 306 in member case 07cv0681).

C. Non-federal Claims

The hydrographic survey reports have been completed, and with few exceptions all known non-Indian water rights claimants have been joined and served with consent order packets pursuant to scheduling and procedural orders. The vast majority of water rights claims have been determined by consent orders and default orders. I requested the plaintiffs to assess the status of all remaining disputed subfiles (see, Status Report, February 28, 2011, No. 2636, and my letter of April 21, 2011, No. 2651), and held a scheduling conference May 31 for the first set of subfiles in order to begin setting them for hearing (May 3, 2011, No. 2654).
