Pursuant to D.N.M.LR-Civ. 5.1 and in compliance with the CM/ECF Administrative Procedures Manual for the United States District Court, District of New Mexico (dated August 28, 2006 and revised February 2015), Craig Fredrickson and Regina Fredrickson (hereinafter Fredricksons), defendants *pro se*, respectfully request the Court's permission to utilize the CM/ECF system for filings in the above-captioned case.


