Suffice to say these individuals are behaving like playground bullies who are intent on taking advantage of younger children who don't know the rules.


These individuals know that I am not a lawyer and that I haven't hired one. They probably also know that I am elderly, and therefore assume that I am easy to take advantage of.

I spent three years of my life defending the freedoms and rights of these individuals and they repay me with this charlatan like behavior? I am deeply chagrined.


**In conclusion** I respectfully request the court to enter an order in my favor and against the United States and the state of New Mexico.



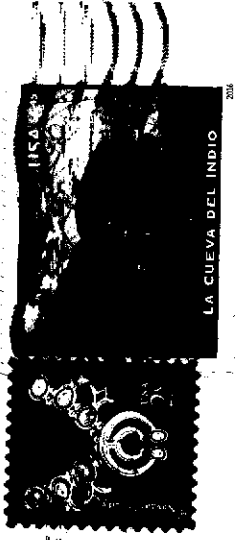
