**UNOPPOSED MOTION FOR EXTENSION OF TIME FOR DEFENDANTS TO
RESPOND TO THE MAGISTRATE JUDGE’S PROPOSED FINDINGS AND
RECOMMENDED DISPOSITION**

NOW COME *pro se* Defendants Craig and Regina Fredrickson (“Defendants”) and hereby request an extension of six (6) days to respond to the Magistrate Judge’s *Proposed Findings and Recommended Disposition* (Doc. 3337). In support thereof, Defendants state as follows:

1. On February 7, 2017 the Magistrate Judge entered his *Proposed Findings and Recommended Disposition* (“*Proposed Findings*”) (Doc. 3337), recommending judgment be granted in favor of the United States and State of New Mexico (collectively, “Plaintiffs”) on Defendant’s water right claims under subfile ZRB-2-0038.

2. Defendant, Craig Fredrickson, is out of the town the remainder of this week and will not be available to work on objections to the Proposed Findings until the week of February 13, 2017.

3. A six (6) day extension will allow the Defendants sufficient time to develop a response.
