**COMES NOW**, the State of New Mexico, the United States, the Zuni Indian Tribe, the Navajo Nation, and various defendants represented by the undersigned attorneys and requests that the Special Master issue Notice of an upcoming Public Information Workshop (Workshop).

The Workshop has been scheduled and planned pursuant to the request of the Special Master during the April 3, 2006, working session with the Special Master. The purpose of the Public Information Workshop, as outlined by the Special Master, is to answer basic questions about the adjudication and the adjudication process. The Workshop will be held at Zuni High School on the Zuni Reservation. The High School is located at Rt. 71, 301N. Signs within the Zuni Pueblo on the Zuni Reservation indicate the direction of the High School. A subsequent Workshop will be scheduled in the future.

The Special Master has indicated that she is receptive to any request to formalize the public information process. As such, the undersigned attorneys request that the Special Master

formalize the public information process by issuing a Notice of the Public Information Workshop. Attached to this Motion is a proposed form of Notice.
