Yates and Trust Q Under the Last Will and Testament of Peggy A. Yates, Deceased.

In addition Yates Petroleum Corporation moves to substitute for it as a party herein YATES RANCH PROPERTY LLP. As grounds this Movant would show the Court that it has conveyed its
